Provisional list of evaluation scores

Following the evaluation by the external peer-reviewers, on February 20th, 2025, the Recruitment Committee, in charge of approving the provisional shortlisted projects (score over 70% threshold) for the 2024 call for the ARISTOS Programme, has agreed:

1.- Approve the provisional list of evaluation scores. Projects with score over 70% threshold, will be called to an interview.

The list of evaluation scores (Annex I) is published in this document. Each candidate will also be informed by email and through the website personal area.

Each proposal was evaluated by three external referees who scored and ranked applications according to the ARISTOS Evaluation Criteria. Priority in case of proposals with the same score (ex aequo) was considered as defined in the table.

DEADLINE FOR REQUESTS FOR REDRESS:

Candidates have the opportunity to submit an appeal against the score of his/her proposal if they believe the score was based on an error in the evaluation procedure. See ARISTOS Redress Template among the templates of the Download area of ARISTOS website https://postdoc-aristos.com/HowToApply

All requests for redress have to be uploaded through the personal area website. The redress will only evaluate the evaluation procedure and perceived incorrect application of the eligibility criteria and not the scientific judgement of the peer reviewers.

IMPORTANT INFORMATION:

Proposals (with score over 70% threshold) will now be screened by the ARISTOS Ethics Committee to check if they comply with the ethical requirements of the call. Ethics review will be performed on the basis of information available in the proposal.

An individual ethics assessment report will be emitted by the Ethics Committee and will be available through the website Personal Area at the end of the evaluation process. Proposals that raise ethics concerns will be flagged for further ethics clearance and if some aspects are incomplete, clarification will be sought. In this sense, research proposals ignoring ethic concerns will be rejected from the Program. Selected Fellows will be required to respond to the Committee's assessment after the acceptance of their project but before the start of their contract.

- ✓ Interviews will be held in English and will be scheduled via videoconference
- Candidates will be judged by the interview panel on their overall merit as researchers, their creativity and level of independence.
- ✓ All interviews will last 45 minutes (maximum), starting with a 10 minutes presentation of the project, followed by a scientific discussion, for the overall assessment of the nonscientific personal skills. The ethical issues and how the proposed project adhere to open science procedures may be addressed during the interviews.

Criteria to be valued during the interview are as follows:

Interview award criteria	Weight
Capacity to defend the project	40
Communication and presentation skills	30
Motivation and enthusiasm for interdisciplinary research	15
Attitude, autonomous thinking, teamwork capacity and leading abilities	15

Each applicant's final mark will be based on the evaluation of the submitted proposal (70%) and the interview assessment (30%). Candidates should again exceed a threshold of 70% in the total score to be appointed. 3. The shortlist will become public on the website (April 2025). Admitted Fellows will then be contacted for the initiation of the hiring process. All contracts are estimated to initiate before the end of May 2025. Appointed researchers will be requested to validate their PhD degree
